RIVER RANCH HAS ISSUED A VOLUNTARY RECALL OF THEIR BAGGED SEPARATE SALAD MIX DUE TO POSSIBLE E.COLI CONTAMINATION.

THE EFFECTED PRODUCT IS LABELED THE RIVER RANCH BRAND AND IS IN A 4x5# PACAKGE WITH ITEM NUMBER 10292 AND JULIAN CODE DATES OF STF 137A3, STF 137A4, STF 138B3, STF 138B4.

IN ADDITION, TAYLOR FARMS HAS ISSUED A VOLUNTARY RECALL OF THEIR ROMAINE BLEND AND SEPARATE SALAD LETTUCES DUE TO POSSIBLE E.COLI CONTAMINATION. THE EFFECTED TAYLOR FARMS LABELED PRODUCTS ARE AS FOLLOWS:

SEPARATE SALAD PACKED ON JULIAN DATE 137 HAS A BEST BY OF 6/1  
SEPARATE SALAD PACKED ON JULIAN DATE 138 HAS A BEST BY OF 6/2

ROMAINE BLEND PACKED ON JULIAN DATE 137 HAS BEST BY OF 5/30  
ROMAINE BLEND PACKED ON JULIAN DATE 138 HAS BEST BY OF 5/31
